 - 4. calling / convening / holding meetings of Board of Directors and its committees and the meetings of the members of the Company on due dates as stated in the Annual Return in respect of which meetings, proper notices were given and the proceedings including the resolutions passed by postal ballot, have been properly recorded in the Minute Book / registers maintained for the purpose and the same have been signed. Further, the Company has not passed any circular resolution during the period under review;
 - 5. closure of register of Members / security holders, as the case may be;
 - 6. the Company has not given any advance or loan to its directors and/or persons or firms or companies referred in Section 185 of the Act;
 - 7. contracts/arrangements with related parties as specified in the provisions of section 188 of the Act;

- 8. there was no issue or allotment or buy back of securities, redemption of preference shares, and there was no alternation or reduction of share capital or conversion of shares/securities. However, there were transfer/transmission of shares and the Company has issued the share certificates in all instances, wherever required;
- 9. keeping in abeyance the rights to dividend, rights shares and bonus shares pending registration of transfer of shares in compliance with the provisions of the Act;

The RoC records on the MCA web portal were, however, updated to reflect the Scheme as effective which inter alia has also resulted into Tatanet Services Limited mentioning as "Amalgamated" with the Company. Based on the legal advice, the Company has approached NCLT to direct RoC to amend its records as if the Scheme has not been effective including to reinstate TNSL to its earlier status as "Active". While, the decision of NCLT is awaited, the Scheme will be given effect to in the records of the Company on receipt of all necessary approvals.
- 15. the Company has not accepted or renewed or repaid public deposits;
- 16. the Company has not borrowed from its directors, members, public financial institutions and others; however the Company has borrowed secured and unsecured loans from banks and the creation / modification / satisfaction of charges were made in that respect, wherever applicable;
- 17. loans and investments or guarantees given or providing of securities to other bodies corporate or persons falling under the provisions of section 186 of the Act;



18. the Company has not altered the provisions of Memorandum and Articles of Association of the Company.
