Based on the legal advice, the Company has approached NCLT to direct RoC to amend its records as if the Scheme has not been effective including reinstating TNSL to its earlier status as "Active". While, the decision of NCLT is awaited, the Scheme will be given effect to in the records of the Company on receipt of all necessary approvals.
15. the Company has not accepted or renewed or repaid public deposits;
16. the Company has not borrowed from its directors, members, public financial institutions and others; however the Company has borrowed secured and unsecured loans from body corporates & banks and the creation / modification / satisfaction of charges were made in that respect, wherever applicable;
17. loans and investments or guarantees given or providing of securities to other bodies corporate or persons falling under the provisions of section 186 of the Act;

18. the Company has not altered the provisions of Memorandum and Articles of Association of the Company.
